The Board authorized Town Counsel Moody to seek a settlement of the matter up to \$5,000.
- 3. The Board discussed the continued bargaining with the Milford Firefighters Association with the Board represented by Attorney Moody. There was discussion of the comparison Attorney Moody previously provided to the Board members as to the status of the respective proposals still in question between the Board of Selectmen and the Firefighters Association. After discussion of the items that were still in dispute, Town Counsel Moody presented the Board with a summary of those matters in dispute and "suggested concepts" for a possible settlement. After reviewing the settlement concepts it was the consensus of the Board to seek a settlement on an "off the record" basis with the Association consistent with the concepts suggested by Attorney Moody.

To agree in price at \$63 million to purchase the Milford Water Company
To continue to negotiate in due diligence on the proposed acquisition
To prepare to schedule a town meeting for mid-March to meet the targeted acquisition date of July 1, 2017

To release the press release as prepared by Town Counsel to the media and general public, UNANIMOUS.

ROLL CALL VOTE: Chairman William E. Kingkade, Jr.; Selectmen William D. Buckley and Michael K. Walsh all vote in the affirmative to go into Executive Session to discuss, Milford Water Company; Town Counsel, re: Claim; Police Chief, re: Nuisance Properties; Atty. Ernest P. Pettinari, Collective Bargaining/Highway Department and Fire Chief, re: grievance.

- 2. Police Chief O'Loughlin was present to provide information regarding the number of public safety calls responding to 75 Highland Street. After a lengthy discussion: It was the consensus of the board to have the Police Chief draft a letter to the Judge and Magistrate of the Milford District Court requesting a meeting to discuss how the community can work with the Court to effectively address quality of life concerns affecting the Milford community.
- 3. Jed M. Nosal, Attorney from Brown Rudnick, Carole Brennan, Principal Strategic Communications and Public Affairs, Town Counsel Moody; and Chris Morin, Chairman/Finance Committee were present.

Ms. Brennan provided a draft of the press release, and mailing regarding a Public Forum scheduled for June 28, 2017 to discuss the proposed acquisition of the Milford Water Company.

Attorney Nosel updated the board on due diligence discussions with the Water Company. After a discussion the consensus of the board was to schedule a meeting with our Consultants and the Lincoln group for July 12, 2017 at 6:30PM.

4. Town Counsel Moody provided an update on the status of the claim for Personal Injuries regarding the Claim of Victor Melendez. Mr. Buckley moved, seconded by Mr. Walsh: To allow Town Counsel to settle the claim in the amount of \$6,000.00, UNANIMOUS.

PRESENT: Selectmen William D. Buckley and Michael K. Walsh; and Town Administrator Richard A. Villani. Chairman William E. Kingkade, Jr. and Minutes Recorder Jean M. DeTore were absent.

- Town Counsel Moody, Jed M. Nosal, Attorney, Sam Williams, Dan Riley, Sarah Wilk, Carole Brennan and Paul Afonso all from Brown Rudnick; David Russell from the Russell Consulting, LLC; Peter Monson, Nancy Parrillo and Don Wallroth of the Lincoln Group, Zachary Taylor, Finance Director and Christopher Pilla, Town Treasurer and Chris Morin, Finance Committee Chairman were present to update the board on due diligence discussions with the Water Company.
- 2. Attorney Jed Nosal of Brown Rudnick updated the Board on the continuing due diligence being done as well as risk mitigation.
- 3. Sam Williams of Brown Rudnick provided a Summary of the due diligence undertaken by Brown Rudnick as of July 10, 2017. He reviewed an Issues Matrix which included the following issues and actions taken to date as well as future actions to be done:
  - Consent of Stockholders
  - Pensions
  - Corporate Formation
  - Employees
  - Debt
  - Related Party Transactions
  - Environmental Issues
  - Assets
- 4. Attorney Williams stated the Water Company pensions look pretty good as he reviewed an actuarial analysis through 2015. He also stated their long term debt totals approximately \$19.8 million. Also, all DEP permits and notices are current.
- 5. Attorney Williams further explained that once the Purchase and Sale Agreement is negotiated and in place its terms will "carve in place" the due diligence process.
- 6. He further discussed indemnifications to be provided by the Water Company to include Selling all Corporate Stock and Corporate Authority to Sell. The Board also agreed to have Brown Rudnick do a Phase I Environmental Report, a Litigation Search, Lien Search and Title Search after providing cost estimates.

- 1. Town Counsel Moody, Carole Brennan from Brown Rudnick; Zachary Taylor, Finance Director and Christopher Pilla, Town Treasurer and Chris Morin, Finance Committee Chairman were present to update the board on due diligence discussions with the Water Company.
- 2. The Board discussed the need for a rate increase for the first year if the Town purchases the Water Company. Selectman Buckley stated it is important to him that the rates remain neutral. He suggested the team look to try to negotiate a reduction in the price that would be rate neutral. If that were not successful, the Town could pursue the process to purchase through the DPU.
- 3. Chairman Kingkade stated the Board has to determine if we want this issue to go to Town Meeting. An important factor is do we want ownership and control of our water supply.
- 4. The Board then recommended the Financial Team provide a purchase price amount that will be rate neutral with only modest rate increases in the future. Once this number is determined the Board can discuss how next to proceed at their next meeting on July 24, 2017.

## MINUTES OF EXECUTIVE SESSION – JULY 24, 2017

## ROOM 03 – TOWN HALL 8:06PM

PRESENT: Selectmen William D. Buckley and Michael K. Walsh; Town Administrator Richard A. Villani; and Minutes Recorder Jean M. DeTore. Chairman William E. Kingkade Jr. was absent. ROLL CALL VOTE: Selectmen William D. Buckley and Michael K. Walsh all vote in the affirmative to go into Executive Session to discuss, Milford Water Company and potential land acquisitions.

1. Jed M. Nosal, Attorney from Brown Rudnick, Carole Brennan, Principal Strategic Communications and Public Affairs, Town Counsel Moody; Finance Director Zachary Taylor; Town Treasurer Christopher Pilla and Chris Morin, Chairman/Finance Committee were present. Finance Director Zachary Taylor informed the board that in order to stay "rate neutral," the purchase price for the Water Company would need to be \$40 Million.

The board asked whether a rate increase of 18% to 20% is enough to effectively run the Water Company. They also stated the town needs to better understand the state of the existing wells. They questioned if the Capital Expenditure Plan provided is sufficient to "run" the wells. The board requested a summary of the Capex Plan, and specifically, what does it do for our ability to draw water. Attorney Nosal will be reviewing the plan prepared by Tata and Howard for the Water Company.

After a discussion, it was the consensus of the board to schedule a second informational forum for September 7, 2017 after the DPU Hearing of September 5, 2017.

- 2. Town Counsel Moody informed the board that an appraisal has been ordered for the potential acquisition of three properties on Central Street. The board also discussed the possible acquisition of property located at the corner of Dilla and Purchase Streets. Mr. Buckley requested that Town Engineer Dean look at this property to see if it is worth pursuing.
- 3. Mr. Walsh moved, seconded by Mr. Buckley: To adjourn executive session at 9:16PM, UNANIMOUS.
