The Board of Assessors reviewed the tax classification hearing presentation.

By operation of law effective November 7, 2016 balances in any separate accounts are merged into a single overlay account. The Board has taken all overlay balances into consideration to make this determination.

The Board reviewed the meal reimbursement guidelines issued by the Finance Director.

The Board attended the tax classification hearing. The Board of Selectmen adopted a residential factor of 0.848200. The resulting tax rates will be \$16.79 residential and \$30.42 for commercial, industrial and personal property.
