A motion to open the meeting was made by Joe Niro and seconded by Joe Arcudi. The motion passed unanimously and the meeting was called to order at 10:00 A.M. in Room 14.

OLD BUSINESS

The Board reviewed the minutes from the May 23, 2016 Board Meeting. A motion to accept the minutes was made by Joe Arcudi and seconded by Joe Niro. The motion passed unanimously.

NEW BUSINESS

The Board reviewed the forest management plan and Chapter 61 application of Maspenock Rod and Gun Club. A motion was made to allow the application by Joe Niro and seconded by Joe Arcudi. The motion passed unanimously. The Board signed the application, certificate and Department of Conservation and Recreation certificates classifying 29 acres for parcel 2-0-2 and 8.2 acres for parcel 2-0-3.

Jennifer informed the Board that the supplemental tax bills issued for condos may need abatement. She is waiting for word from the Department of Revenue.

Connection to the patriot server has been lost on a few occasions and and days of down time have been experienced. Lawney and Andrew say there is a plan to improve the connectivity to be implemented after July 1, 2016.

The Board reviewed the 2016 proposed equalized values from the Bureau of Local Assessment. The Board was satisfied with the proposal totaling \$3,206,234,500.

The Board reviewed and signed the omitted and revised assessment report. The Board also reviewed and signed the amended growth report. Both submissions will be completed online.

The Board reviewed the Clause 18 policy adopted by the Board 9/9/2014. Joe Niro made a motion to eliminate the requirement that the applicant attend a meeting to discuss what steps they are taking to improve their situation. The applicant may be called to a meeting, but only if necessary.

Jennifer informed Rick Villani that Manguso Avenue and Manguso Court are the same road. The street acceptances were done at separate times. The Town may wish to bring an article to town meeting to correct this error.
