All changes have been made in Patriot. It was also discovered that Kelley and Ryan was changing mailing addresses through a program using postal information. Address changes will not be made in the future without authorization from the property owner.

On January 12, 2016 and February 10, 2016 the Board of Assessors met with two members present and one member participating remotely. It has come to our attention that remote participation has not been adopted in Milford.
