### **MINUTES JANUARY 3, 2017**

#### **OLD BUSINESS**

The Board reviewed the minutes from the November 21, 2016 Board Meeting. A motion to accept the minutes was made by Joe Niro and seconded by Joe Arcudi. The motion passed unanimously.

### **NEW BUSINESS**

The Board received notification from Rick Villani that the unexpired Board of Assessors vacancy will be included on the April 4, 2017 ballot.

The Board of Assessors reviewed the memorandums from the Department of Revenue and the MAAO regarding the pending appeals for Verizon New England Inc.

The DOR and Verizon have reached an agreeable depreciation methodology for central valuation. The proposed methodology would not be appealed through FY2022. The resulting abatement for each account would be equal to 7% of value with no interest for FY2010 through FY2016. No refunds for FY2017. The DOR has asked for feedback to this proposed resolution. Jennifer has consulted with the Finance Director and Town Counsel.

The total tax dollars Milford would abate for FY2010 through FY2016 is \$191,778.90. The MAAO is in support of this proposed settlement.

A motion was made Joe Niro to notify the DOR of Milford's favorable support of this resolution. The motion was seconded by Joe Arcudi. The motion passed unanimously. Jennifer will send the DOR an email to that effect.

The Board would like to include a memorial in the Annual Town Report for Sam Bonasoro. Jennifer will reach out to Cheryl Bonasoro.
