abate \$271,200 in value with no interest for FY 2012. The motion was seconded by Joseph Arcudi. Motion passed.

The Board reviewed negotiation information on a FY2011 ATB case # F312019 and FY 2012 ATB case # F315315. A motion was made by Joseph Niro to approve an agreement to withdraw both cases for parcel #48-0-59, Claflin St. Ltd. Partnership. The motion was seconded by Joseph Arcudi. Motion passed.

The Board reviewed negotiation information on a FY2011 ATB case # F312018 and FY 2012 ATB case # F315316. A motion was made by Joseph Niro to approve an agreement to withdraw these cases for parcel 48-0-59, Claflin St. Ltd. Partnership. The motion was seconded by Joseph Arcudi. Motion passed.

The Board reviewed negotiation information on a FY2011 ATB case # F310501. A motion was by Joseph Niro to approve an agreement to withdraw this case for parcel #32-0-7, CVS Pharmacies. The motion was seconded by Joseph Arcudi. Motion passed.

Priscilla reviewed with the Board the new legislation for Towns to be able to accept, as local option, a work-off program for Veteran's that is similar to the work-off program for Senior. Joseph Niro made a motion for Priscilla to advise the Board of Selectmen of this new legislation. The motion was seconded by Joseph Arcudi. Motion passed.

Each Board member received a copy of the 2012 Town of Milford Committee Handbook.

The Board reviewed a letter from Rui Pereira thanking them for their efforts put forth for him to receive a stipend for a foreign language translator.
