The Board signed land of low value statements for submission to the Department of Revenue for parcels 59-0-2A and 8-0-36.

A motion was made by Joshua Lioce to abate the personal property uncollectable taxes and seconded by Joe Arcudi. By roll call, Joshua Lioce – Yes, Joe Arcudi – Yes, Joe Niro – Yes. The motion passed unanimously. The list of FY 2014 abatements is attached totaling \$4,626,26.

A motion was made by Joshua Lioce to reassess the real estate taxes for parcel 42-0-208 and seconded by Joe Arcudi. By roll call, Joshua Lioce – Yes, Joe Arcudi – Yes, Joe Niro – Yes. The motion passed unanimously. The list of reassessed taxes from the Heirs of Horace Claflin to the Town of Milford for fiscal years 1986, 1987, 1992 – 2020 is attached totaling \$5,824.79.

The motion passed unanimously. The net abatements total \$17,088.01 after the Medicare and OBRA deductions. The list is attached.

The Board discussed the status of the office and concerns with the coronavirus. The number of cases is increasing, students are on breaks and the holidays may worsen the situation. Recently a town department has had an exposure and subsequent quarantine of all staff. Town Hall continues to be open to the public. Joe Arcudi is concerned for the safety of the employees and thinks the Town should close to the public for December. Joe Niro asked about testing employees, which we were informed there was no logistical way to do that. Joshua wants to know if our staff is equipped in case we are quarantined.

The Board asked Jennifer to put together an emergency plan for the office and communicate the concerns of the Board to the Board of Health, Board of Selectmen and Rick Villani.
