7:04 P.M.- Discussion- Town Engineer Elizabeth Mainini stated she received an email about certain areas where hunting is permissible.

Motion by Atherton, second by Braza to continue. Motion carries. four in favor, one abstention (member Roda).

Present at the hearing was Justine Carroll, P.E from Tata & Howard and Jonathan Bruce

Ms. Carroll stated replacement wells being proposed. Wells will not be in wetlands; piping will go through wetlands but will remain within the existing cleared paths.

Town Engineer stated all disturbance is temporary, recommends and an issuance of an order of conditions.
