Minutes – 4-13-11 will be corrected.

Parks Department Budget: Level funded in all areas except utilities. Total budget is \$592,000. John Tennaro moved to accept the Parks Department budget as presented, seconded by Chuck Miklosovich, all in favor.

Article 35 – Park Commissioners – Well and pump station at Fino Field and Votolato Field - \$35,000. Aldo Cecchi moved for a favorable recommendation for \$35,000 on Article 35, seconded by John Tennaro, all in favor.

Yourth Center Budget: Total Budget \$50,147. Vinny Valstro moved to accept the Youth Center budget as presented, seconded by Dave Morganelli, all in favor.

Vernon Grove Cemetery Budget: Total \$101,162. Al Correia moved to accept the Cemetery budget as presented, seconded by Aldo Cecchi, all in favor.

Article 36 – Vernon Grove Cemetery Trustees – Transfer available funds to be spent for the purpose of laying out remaining lots. Aldo Cecchi moved for a favorable recommendation, seconded by John Tennaro, all in favor.

Highway Department Budget: There is an increase in the gas line item due to the higher gas prices. Recommendation of the committee is to add \$5000 to the gas line item. Salary increase of 2 ½ percent and an increase of \$1200 in electricity. John Tennaro moved to increase the fuel line item by an additional \$5000, seconded by Aldo Cecchi, 6 in favor, 5 opposed.

Budget line item 421: \$925,383. Vinny Valastro moved to accept budget line item 421 as presented, seconded by John Tennaro, all in favor.

Budget line item 422: \$922,860. John Tennaro moved to accept budget line item 422 as presented, seconded by Al Correia, 9 in favor, 2 opposed.

Budget line item 423: \$500,000. Vinny Valastro moved to accept budget line item 423 as presented, seconded by Mike Schiavi, all in favor.

Article 32 – Highway Surveyor - \$20,000 – Storm Water Management compliance. Aldo Cecchi moved for a favorable recommendation, seconded by Chuck Miklosovich, 10 in favor, 1 opposed.

Article 5 - Treasurer – Borrow money with approval of the Board of Selectmen. Aldo Cecchi moved for a favorable recommendation, seconded by John Tennaro, all in favor.
