Aldo Cecchi indicated that the Committee would reconvene in a regular meeting after the discussion.

7:58 p.m. Aldo Cecchi moved to come out of Executive Session, seconded by John Tennaro, ROLL CALL, all in favor.

8:00 p.m. – Regular session reconvened.

Article 22 – Police Chief - Seek special legislation – Bob DeVita moved for a favorable recommendation, seconded by Aldo Cecchi, 5 in favor, 6 opposed.

Article 24 – Police Chief – To see if town will amend Article 13, Section 16 - Aldo Cecchi moved for a favorable recommendation as presented by the chief of police, seconded by John Tennaro, all in favor.

Article 33 = Police Chief – To see if the town will vote to enable the Police Department to conduct State and Federal finger print based criminal history. Aldo Cecchi moved for a favorable recommendation, seconded by John Tennaro, all in favor.

Article 10 – Selectmen – Contracts for or on behalf of the Town. John Tennaro moved for a favorable recommendation, seconded by Vinny Valastro, all in favor.
