
V. ADJOURNMENT

Upon motion duly made by (Paul Braza) and seconded (Joe Arcudi) the Park Commission voted (3-0) to adjourn the meeting.


Having no additional business, the Park Commission adjourned its meeting on Thursday March 4, 2021 at or about 5:05pm.




