#### 5. Old Business

- H. Rhodes discussed revising the current By-Law 5.5 Bereavement Policy. He feels that Miscarriage/Stillborn should be added to the list of Family Members. J. Nosiglia indicated if Children are listed then that would cover it. H. Rhodes said he discussed with Town Counsel Boddy and would just like to clarify and add it on.
- H. Rhodes asked M. Giffin to go over By-Law 5.8 Vacation Carryover. M. Giffin indicated it is just a clarification and no change. Current by-law says you can carry over up to 10 days however 5 of said days must be used by June 30<sup>th</sup>. The change would be to still carry over up to 10 days with anything over 5days to be used by June 30<sup>th</sup>. Ex: Carry 8 days, 3 must be used by June 30<sup>th</sup>.
