Gerry Ruska 12 Redwood Road asked about lighting. This is zoning by-law only tonight. Antonio DeMoura 15 Senate Road feels no need for a tall school It is in his backyard. Need more control. Illegals here and that causes need for more schools.

Marble Mainini III states old school was built too low. Wetlands here. Feels they did a good job of bringing height down 2.5 stories. He is in favor.

Jian Gao Has studied this project. feels wrong to change the law for this building Much concern Not fair to the people.

Marble Mainini III states Board makes recommendation only. He has High School in h is back yard.
