## MINUTES OF REGULAR SESSION – November 30, 2023 ROOM 03 – TOWN HALL 4:00 PM

PRESENT: Chairman Paul A. Mazzuchelli and Select Board members Michael K. Walsh and Thomas J. O'Loughlin and Town Administrator Richard A. Villani.

- 1. A Public Hearing was held for an application for the transfer of a Class I License from Imperial Hyundai Corporation DBA Genesis of Milford to MAG Retail Holdings HMI, LLC dba McGovern Hyundai of Milford for the business located at 154 East Main Street, Milford. All paperwork was in order. Michael Penner was present on behalf of MAG Retail Holdings. John Kennedy was present on behalf of Imperial Hyundai Corporation. Mr. Penner said he will be running the dealership. Mr. O'Loughlin moved seconded by Mr. Walsh: To issue the Class I license to MAG Retail Holdings HMI, LLC dba McGovern Hyundai of Milford for the business located at 154 East Main Street, Milford on the condition that Imperial Hyundai Corporation DBA Genesis of Milford turns in its current license on the same day MAG Retail Holdings picks up its new license. UNANIMOUS. No individuals attended the Hearing via Zoom or in person.
- 2. Highway Surveyor, Scott Crisafulli, was present to discuss The Public Works Mutual Aid program. He recommended the Board consider Milford becoming a Mutual Aid Town. He said participation in the Program takes the weight off the Town in an emergency trying to deal with public safety. He said this will allow Milford to receive assistance from other Towns in cases of emergency. We will also assist other Towns in cases of emergency. Mr. O'Loughlin said the sharing of resources among Towns "makes sense." Mr. Walsh said it is good to have other Towns as a "backup in emergency situations". Mr. O'Loughlin moved, seconded by Mr. Walsh: To authorize, through the Highway Surveyor, for the Town to participate in the Public Mutual Aid Program, and to authorize the Parks Department, Water Department and Sewer Department to receive and provide needed services in cases of emergency. UNANIMOUS.
- 3. Mr. O'Loughlin moved, seconded by Mr. Walsh: To accept a Gift from Central One Federal Credit Union to the Milford Veterans Department in the amount of \$1,000.00. UNANIMOUS.
- 4. Mr. O'Loughlin moved, seconded by Mr. Walsh: To adjourn the Select Board meeting at 4:16 PM, UNANIMOUS.
