
Chairman Walsh opened the Meeting.

1. Attorney Jed Nosal of Brown Rudnick was present to update the Board on the DPU process, the expense budget to date and a Water Company proposal regarding capital for 2019. He informed the board that we are now in the Discovery Process. The next phase will be to file rebuttal testimony, then further discovery and finally the Evidentiary Hearing in May. The three main issues are the valuation formula to be applied, the value of the real estate and the depreciation method. He next discussed the expense budget. Due to the complexity of the case and the size of the Water Company filing and the fact that they have added witnesses will result in increased discovery and hearing time. He informed the board of the need to hire a real estate appraiser at an additional cost of \$30,000.00. He also stated there will be increased expense for our consultants Concentric Energy and Woodward and Curran as well as for Brown/ Rudnick. He estimated the need for an additional \$185,000.00 plus a contingency of \$100,000.00. Mr. Kingkade moved, seconded by Mr. Buckley: To approve the appropriation of \$285,000.00, subject to Town Meeting approval. Mr. Buckley moved, seconded by Mr. Kingkade to enter into a contract with CBRE up to the amount of \$30,000.00 without further appropriation from the Board. UNANIMOUS.

Selectman Kingkade, Finance Director Taylor, Town Treasurer Chris Pilla and Finance Committee Chairman Chris Morin left the meeting at 8:26 PM.

- Town Counsel Boddy was present and provided a Memo to the Board updating them
  on the status of the negotiations with the Police Union regarding a new contract. Mr.
  Buckley moved, seconded by Mr. Walsh: To approve the Memorandum Agreement



Mr. Pighetti entered the room at 6:16 PM.

Mr. Pighetti said he planned to speak with individuals in the Department, review the budget and ongoing investigations. He would be seeking benefits in a contract to include: Injured on Duty, Loss of Life, Bereavement Leave, Vacation Time, Holidays, Liability Indemnification, uniform and clothing allowance, professional development, a vehicle and Life Insurance Coverage. He also would be seeking a one (1) year contract.

Mr. Kingkade stated he would like to include a Transitional Period in the contract to overlap with the new Police Chief coming on board.

Mr. Walsh asked what is the title for the position - Chief of Police or Administrator? He said if he is a Police Chief he would have to attend the academy for training. If he is an Administrator, he would not have Police powers.

Town Counsel Boddy stated the Title is Administrative Chief and he would not have Police powers. He is not entitled to a waiver of the training, but could ask the Training Committee what activities he needed to undertake to exercise Police powers. He suggested inserting in

the contact a clause that it could be reopened if he acquires the ability to exercise Police powers.

Mr. Buckley requested Town Counsel render an opinion on an Administrative Chief and begin drafting an outline of the contract.

The Board next discussed scheduling a meeting on Wednesday, May 20, 2019 at 6 PM to continue negotiations with Mr. Pighetti.

The Board then took this matter under advisement.

Mr. Pighetti left the room at 7:15 PM.

Mr. Pighetti informed the board that the has spoken with a representative from PERAC and they want to review the final contract. He also reached out to the Training Committee and is waiting to hear from them. He may appear before the Committee to plead his case. Mr. Pighetti stated he spoke with Finance Director, Zach Taylor, and was informed if he accepts Option B, the amount he can receive would increase to \$62,000.00. The Board asked for an updated breakdown on pension amount and salary from the Finance Director.

Mr. Pighetti stated he would consider a salary within five (5) percent of the total of his pension and the maximum he could receive from the Town which he estimated at between \$124,000.00 and \$128,000.00.

The Board agreed to schedule a meeting for Wednesday, May 29, 2019 at 6:00 PM to continue negotiations. They asked Mr. Pighetti to be present at 6:15 PM.






