## MILFORD BOARD OF SEWER COMMISSIONERS MINUTES March 21, 2017

The Sewer Commissioners Meeting was called to order at 6:00 P.M. in room #14 of the Milford Town Hall.

A motion to approve the February 21, 2017 Meeting Minutes was made by Mr. Cenedella, seconded by Mr. Morelli.

A motion was made to have the next Sewer Commissioner's Meeting on April 18, 2017 at 6:00 P.M. in Room #14 of the Town Hall, by Mr. Cenedella, seconded by Mr. Morelli.

A motion was made by Mr. Cenedella to Approve Sewer Connection Permits for 23, 25, 27, 29, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 46, 48 & 50 Beaver Pond Road, seconded by Mr. Morelli.

A motion was made by Mr. Cenedella to approve an Amended Site Plan Review for 285 West Street as it has no effect on Town Sewer and send a letter to Milford Planning Board, seconded by Mr. Morelli.

A motion to approve an Amended Site Plan Review for 350 East Main Street was made provided that the kitchen and lounge are connected to the existing grease trap and send a letter to Milford Planning Board by Mr. Cenedella and seconded by Mr. Morelli.

Mr. Landry and Mrs. Cavaliere informed the Board that the General Bid for the Sludge Handling Facility has been postponed from March 22, 2017 until March 29, 2017. They are getting a lot of questions from General Contractors. They noted that it's a big project and that they have some good contractors on the list.
