

There are several other changes like their uniforms can no longer look like a Police Officer. This proposed policy addresses in detail what they can and can't do as a Traffic Constable.

Town Counsel Gerry Moody has reviewed the policy and made several recommendations and was very helpful.

With the loss of the Auxiliary Police Force due to changes in the law from Police Reform, I believe this proposal if approved would help the Milford Police Department to better serve the town of Milford in many ways.

### I. GENERAL CONSIDERATIONS AND GUIDELINES

The need for competent and safe traffic control throughout the town of Milford is a paramount concern. Primarily, traffic details are performed by police officers. The purpose of this policy is to establish civilian Traffic Constables to provide traffic detail coverage when no full-time or special police officer is available to perform such function.

#### II. POLICY

Traffic Constables will be assigned to direct and control traffic to ensure its smooth and safe flow. Traffic Constables must demonstrate a firm commitment to carry out assignments in a competent, timely, and professional manner. It is the policy of the Milford Police Department to provide guidance to Traffic Constables through various policies, procedures, regulations and trainings, which have been established to direct members in the performance of their duties and responsibilities. Additionally, this policy is meant to address the following:

- A. To clearly state Traffic Constables do not have the status of sworn law enforcement officers or regular Constables.
- B. To describe the duties of Traffic Constables.
- C. To ensure that Traffic Constables are trained in the duties which they are expected to perform.
- D. To ensure the uniforms of Traffic Constables are clearly distinguishable from those of sworn police officers.

#### III. DEFINITIONS

A. Traffic Constable: a non-sworn per diem employee of the town of Milford Police Department whose duties are restricted to traffic control, direction and work zone safety only.

#### IV. PROCEDURES

- A. Traffic Constables are not sworn police officers and are not covered by M.G.L. c. 41 § 98 or c. 41 § 111F. They have absolutely no authority to issue citations, effect seizures, serve warrants and other process, or make arrests.
- B. Traffic Constables are appointed by the Select Board, upon recommendation of the Chief of Police, for a period of one year.
- C. All Traffic Constables must pass a criminal background check prior to assuming any duties, if not a retired Milford Police Officer.
- D. There is no automatic renewal.
- E. A Traffic Constable's availability and frequency of work may contribute to any decision regarding reappointment.
- F. Traffic Constables shall submit a Letter of Interest to the Traffic Constable Supervisor each year by May 1st requesting to be reappointed.
- G. Traffic Constables shall provide a letter to the Traffic Constable Unit Supervisor each year by May 1st, signed by a registered physician, stating such person is capable of performing the duties of a Traffic Constable as described in this policy.
- H. Traffic Constables shall inform the Traffic Constable Supervisor of any medical condition which could impact the performance of their duties as a Traffic Constable.
- I. The power of Traffic Constables is strictly limited to the direction, control, and regulation of vehicular traffic. Such power shall only be exercised when in uniform, and only while performing an official assignment given by the police department.
- J. Traffic Constables shall obey, without reservation, the regulations of the department and all lawful commands of police officers.
- K. Traffic Constables are used, at the sole discretion of the Chief of Police, to direct traffic and facilitate the smooth flow of vehicular and pedestrian traffic.
- L. The Chief of Police, or designee may require Traffic Constable Members to assist.

- M. Traffic Constables are not covered by any collective bargaining agreement.
- N. Traffic Constables are not covered by any collective bargaining agreement and as such do not have any right of grievance.
- O. Upon request, Traffic Constables shall support, aid, and assist police officers in the lawful performance of their duties.

#### **DUTIES**

- A. Working at assigned locations; performs traffic control duties including manually directing traffic, operating traffic signal controls and placing traffic cones and barricades to safely direct and control traffic flow.
- B. Renders assistance to motorists when appropriate.
- C. Assists the public with information regarding directions, street locations, points of interest, etc.
- D. Observes and reports hazardous conditions/situations.
- E. Reports to the Shift Supervisor / OIC when necessary and receives direction from the same.

#### **WEAPONS**

Traffic Control Constables are not authorized to wear a badge, carry a firearm, baton, pepper spray or any other weapon of any kind while on duty as a Traffic Control Constable.

#### TRAINING / KNOWLEDGE / SKILLS

- A. Traffic Constables may be required to complete any such annual inservice training as required by the Chief of Police. CPR will be required annually.
- B. Knowledge of hand traffic signals, cone/traffic patterns and manual operation of traffic signals is required.
- C. An initial safety course may be required for all constables who are not former police officers; such as, the MMA MIIA "Work Zone Safety for Public Works Highway and Police" course or their "Work Zone Safety" course.
- D. Knowledge of the town's geography, streets, and business is required.

#### UNIFORMS and EQUIPMENT

- A. Traffic Constables shall wear the following uniform while on-duty:
  - 1. Pants: Black uniform/BDU style pants in good order.

- 2. Shirt: ANSI Approved (green) short or long sleeve shirt (Traffic Constable Patches on both shoulders) Stenciled "TRAFFIC" on back.
- 3. Jacket: ANSI Approved (green)
- 4. Hat: Black baseball style with mini Traffic Constable Patch affixed on front of hat
- 5. Foot Wear: Black boot/shoe/sneaker
- B. Traffic Constables must be equipped with a flashlight when working in evening lighting conditions.
- C. High Visibility reflective shirts and outerwear jackets must be stenciled "TRAFFIC" in white and meet the ANSI standards.
- D. All uniforms and equipment will be purchased by the Traffic Constable.
- E. Traffic Constables are not allowed to operate police department vehicles and they are not allowed to obtain a Blue Light Permit for their personal vehicle.

#### COMMUNICATION

Traffic Constables shall be issued a portable radio when available in order to effectively keep two way communications. Portable radios are department property and must be properly maintained and securely kept. Any damaged or lost portable radio must be immediately reported to the Shift Supervisor detailing the circumstance regarding the damage or loss.

#### **VIOLATIONS**

Any violations of this policy may result in a suspension or revocation of appointment as a Traffic Constable, as determined by the Chief of Police.

Comprehensive Permit – Request for Insubstantial Change

Dear Mr. Consigli:

On behalf of Milford Avalon, Inc., a limited dividend corporation and wholly owned subsidiary of AvalonBay Communities, Inc. (the "Applicant"), in conjunction with 88 Corp., as land owner, this letter is a request that the Milford Zoning Board of Appeals (the "Board") determine that the proposed changes described below are insubstantial changes to the Development (as defined below) pursuant to 760 CMR 56.05(11) of the regulations governing comprehensive permits issued under M.G.L. c. 40B. Submitted herewith are plans relative to the proposed changes. A reduced version of the new site plan is attached to this letter as Exhibit A (the "Modified Site Plan"). A list of new site plan drawings which are being submitted with this letter is attached hereto as Exhibit B (the "New Site Plan Drawings"). A list of new architectural plans which are being submitted with this letter is attached hereto as Exhibit C (the "New Architectural Plans", and together with the Modified Site Plan and the New Site Plan Drawings, the "Modified Plans").

Please note that the submission of this letter and the requested changes are without prejudice to the Applicant's rights under the existing Comprehensive Permit (as defined herein) for the Development, all of which the Applicant reserves. Without limiting the generality of the foregoing, the Applicant (i) does not abandon any of its rights under the existing Comprehensive Permit, and (ii) reserves the right at any time to withdraw the requested changes and to proceed with the Development as set forth in the existing Comprehensive Permit for whatever reason, including, without limitation, if the requested changes are not permitted by the Board, if an appeal is taken by any party with respect to such changes, if other necessary permits, approvals and consents for the requested changes are not approved, or if the Applicant does not proceed with the Development.

#### I. BACKGROUND

1. On or about December 28, 2017, 88 Corp. applied for a comprehensive permit pursuant to M.G.L. c. 40B to construct one hundred sixty-two (162) units of rental housing and

three hundred twenty-four (324) parking spaces on approximately 27.32 acres located at Lot 31, Birch Street (the "Development Site"), Milford, Massachusetts.

- 2. The Board issued a comprehensive permit (as subsequently amended, the "<u>Comprehensive Permit</u>") by virtue of a Decision (the "<u>Original Decision</u>") dated as of July 17, 2018 and filed with the Milford Town Clerk on July 27, 2018.
- 3. As set forth in the Original Decision, the Original Development was to consist of up to one hundred sixty-two (162) units of rental housing in no more than four (4) buildings, including a clubhouse, recreational facilities and associated infrastructure improvements, and no more than three hundred twenty-four (324) parking spaces (the "Original Development").
- 4. Construction and Bonding Condition #31 and Section G of the Original Decision contemplate potential changes to the Original Development, which changes may be determined by the Board to be insubstantial changes or substantial changes, as those terms are used in 760 CMR 56.05(11).
- 5. On or about November 21, 2019, 88 Corp. applied for approval of a number of changes to the Original Development, including: (i) reducing the number of residential buildings from four (4) to three (3), with the addition of a new floor on each residential building; and (ii) integrating the clubhouse and residential facilities with the residential buildings (the Original Development, as so modified, the "Development"). The Board issued a Decision approving the modifications to the Original Development as a substantial change, which Decision is dated as of January 8, 2020 and filed with the Milford Town Clerk on January 8, 2020.
- 6. By this letter, the Applicant requests as insubstantial changes to the Comprehensive Permit the following: (i) changes to the approved plan as reflected on the Modified Site Plan; and (ii) certain other modifications to the Comprehensive Permit as set forth below.

#### II. PROPOSED MODIFICATIONS

The Applicant's proposed modifications to the Development constitute certain minor modifications to the buildings' dimensionality, elimination or reallocation of previously approved amenities spaces, and the reconfiguration of parking fields. As addressed in Section III below, 760 CMR 56.07(4)(c) sets forth certain criteria which are generally considered a substantial change to a Chapter 40B project: (i) a 10%<sup>+</sup> increase in building height; (ii) a 10%<sup>+</sup> increase in proposed units; (iii) a reduction in site size of 10%<sup>+</sup> in excess of any decrease in proposed units; (iv) a change in building type; and (v) a change from one form of housing tenure to another. The proposed modifications to the Development do not meet any of these criteria.

- 1. Changes to the Plan: The Modified Plans include the following changes:
  - (a) The replacement of the currently contemplated dwelling units with the Applicant's prototype dwelling units, which units are largely within the previously approved building footprints as depicted on the diagram attached hereto as Exhibit D.

- (b) The buildings' maximum building height shall be the same or lower than then the previously approved Development.
- (c) The reconfiguration of Development amenities, including the elimination of the pool area, to allow for (i) a reconfigured, more efficient parking field (which shall continue to have 324 parking spaces, as previously approved), and (ii) a landscaped barbeque area with outdoor seating, all as depicted on the Modified Plans.

Although the primary elements of the utility and grading plans will remain unchanged from those approved by the Comprehensive Permit, there may be minor changes to account for the Modified Site Plan. If the Board requires additional information on these minor changes, the Applicant can provide additional detail.

Except for as otherwise set forth above, the overall plan remains essentially the same as was approved by the Comprehensive Permit. The final plans for the Development will be updated to be consistent with the Modified Plans. All references to the plans in the Comprehensive Permit will be modified to mean the original plans as modified by the Modified Plans.

- 2. Extension of Comprehensive Permit's Term. Notwithstanding anything to the contrary as set forth in Section E.1 of the Original Decision, the Applicant requests to extend the date on which the Comprehensive Permit will lapse, pursuant to 760 CMR 56.05(12)(c), to July 1, 2023.
- 3. <u>Changes to Request for Waivers</u>. The Applicant requests modifications to the Request for Waivers previously approved by the Board as Exhibit C to the Comprehensive Permit to reflect the changes to the Development as reflected in the Modified Plans.
- 4. <u>Change in Subsidizing Agency</u>. By this letter, the Applicant also wishes to notify the Board that it is evaluating whether to change its subsidizing agency from MassHousing ("<u>MassHousing</u>"), the subsidizing agency that issued the Project Eligibility Letter for the Development, to the Department of Housing and Community Development ("<u>DHCD</u>") through its Local Initiative Program ("<u>LIP</u>"). The Applicant has been in communication with the Select Board regarding this potential conversion. The contemplated change in subsidizing agency will not affect any other aspect of the Development. Accordingly, by this letter, the Applicant is requesting the ability to convert the Development to a LIP project. Should that occur, the Town will be a party to a regulatory agreement between the Applicant, DHCD and the Town, and there will be no need for a so-called "springing regulatory agreement" as referenced in Condition 7 to the Comprehensive Permit.

#### III. DISCUSSION

As set forth in 760 CMR 56.05(11), after the issuance of a comprehensive permit granted by a zoning board, an applicant desiring to change aspects of its proposal may notify the board in writing. The factors to take into account when determining whether a change is substantial or

insubstantial are set forth in 760 CMR 56.07(4)(c) and (d), respectively. The minor proposed modifications to the Development contemplated herein, as described above, clearly do not involve the types of material changes set forth in 760 CMR 56.07(4)(c). Rather, with regard to the plan changes, the proposed modifications to the Development are the types of changes that are not described as substantial changes in 760 CMR 56.07(4)(d), as follows:

- (1) there will be no increase in the buildings' heights;
- (2) there will be no increase in the number of proposed units;
- (3) there is no change in the building types;
- (4) there is no change from rental property to home ownership; and
- (5) there will be no reduction in site size.

Further, a change in subsidizing agency (addressed above) that does not affect any other aspect of the project is expressly listed at 760 CMR 56.07(d)(5) as a generally insubstantial change; the contemplated change in subsidizing agency to DHCD will not affect any other aspect of the Development.

The Applicant respectfully requests that the Board consider this matter at its next regularly scheduled meeting.


