#### **Document 002100-INSTRUCTION TO BIDDERS**

Add the following Article to page 7:

#### **Taxes**

The Bidder shall not include in this bid any tax imposed upon the sale or rental of tangible personal property in this Commonwealth, such as any and all building materials, supplies, services and equipment required to complete the work. The Town of Milford is exempt from payment of the Massachusetts Sales Tax, and the Bidder shall not include any sales tax on its bid. The Town's exemption number will be provided to the successful bidder.
