

A GUIDE TO REPRESENTATIVE TOWN MEETING

How Can I Become a Town Meeting Member?:

There are thirty elected members per precinct. A third of which are elected every year in the local election, for a three-year term.

You can become an elected T.M.M. by obtaining nomination papers at the beginning of the year for the local election. You would obtain thirty or more (30+) signatures of registered voters within your own precinct on your nomination papers. You would then return all signatures on the nomination papers to the Town Clerk's office to be verified by the Board of Registrars within the allotted time indicated on the election schedule. If you have obtained sufficient signatures, you will be placed on the ballot (in random order) for the Town Election. If you are successfully elected at the Town Election you will receive notification of such election by mail.

OR

You could obtain nomination papers before the Annual or Special Town Meeting (if any remaining openings are available within your precinct). You would obtain thirty or more (30+) signatures of registered voters within your own precinct. The signatures on the nomination papers would be returned to the Town Clerk's Office to be verified by the Board of Registrars at least Twenty-eight (28) days before any scheduled Town Meeting. If it has been verified that you have obtained sufficient signatures, a notice will be mailed to the Town Meeting Members in your Precinct that an election will take place before the scheduled Town Meeting. If you are successfully elected by your fellow precinct members at Town Meeting you would then be sworn in by the Town Clerk before the Town Meeting begins to be able to participate and vote in your precinct.

What Issues are Voted?:

You vote on the motions as presented on the floor. The general content of these motions are outlined in the Warrant. The basic purpose of the Warrant Articles is to advise you of the subject matter to be considered at the meeting. The motion may not be exactly as worded in the warrant article. All action must be taken as result of a motion presented to the body. An amendment is an addition to, deletion from or substitution of wording in the original motion. An amendment to a motion requires a majority vote and is debatable. If an amendment is successful, it is included in the main motion. There can be only two amendments to a motion on the floor at one time and each must be voted on separately.

How Do You Vote?:

A VOICE vote is *usually* taken. A voice vote can be doubted by at least seven (7) members by standing after the moderator announces the vote. Each precinct is polled by a STANDING vote. Other methods include Roll Call Vote, which requires a majority vote; and a Secret Ballot Vote, which requires a two-thirds (2/3) vote.

How Are Motions Made?:

Main motions and amendments must be in writing. After being recognized by the moderator, the member reads the motion or amendment and presents it to the moderator.

Rules on Debate:

Recognition of speakers by the Moderator is based on the principle that everyone should be allowed to speak once an article is presented for discussion. All questions must be addressed to the Moderator. Member should stand, raise hand, and loudly state "Mr. Moderator" until recognized. Member should then give his name and precinct before beginning to speak to the Moderator.

Points of Order:

Members can interrupt a speaker by asking for a "Point of Order" any time they're uncertain whether or not the speaker is entitled to the floor, whether the speaker is being indecorous, frivolous, or irrelevant. Obtain the attention of the moderator and say, "I rise to a point of order", and then wait to be recognized
