#### INTRODUCTION

In June of 2014, Reno DeLuzio, a Town Meeting Member for over 40 years, petitioned the Citizens for Milford (CFM) to organize a Town Meeting Improvement Initiative. CFM is a volunteer, nonpartisan, grassroots organization whose mission statement includes,

"coordinat[ing] projects and events that address current issues that seek to improve the quality of life in our community". CFM accepted the project and after some initial strategizing prepared a methodology to address the initiative. The methodology was presented to the Board of Selectmen in September 2015 who unanimously supported the initiative and the methodology.

Although later than anticipated, the following 13 member Town Meeting Working Group (TMWG) was established to manage the initiative:

#### The TMWG proceeded to implement the methodology as follows:

- a) Researched other Towns to get a sense of what is being done to improve their Town Meeting form of government.
- b) Worked with a professional survey company to develop this survey questionnaire and distributed it to Town Meeting members and Members at Large for their input.
- c) Based on the survey results, prepared a prioritized list of improvements to pursue.
- d) Petitioned the October 30, 2017 Special Town Meeting (Article 15) to establish, by standing vote, a Town Meeting Study and Improvement Committee (TMSIC) to transition the initiative from the volunteer TMWG to the TMSIC. The TMSIC is comprised of nine (9) elected Town Meeting Members, one (1) from each of the eight (8) precincts and one (1) from the body to achieve an odd number. Town Meeting approved the motion.

The TMSIC will, **for the very first time**, provide an official and continuous mechanism to study and pursue the improvements recommended in the Survey. These improvements will bring Milford's Town Meeting into the 21<sup>st</sup> century by using current technology and practices to make it a more informative and pleasant experience and thereby preserve this form of government for future generations.





## 1. Opportunity to become involved, informed, and participate in the decision process

An opportunity to be better informed about issues facing the town.

Being involved with our town's development.

Necessary materials are provided in advance so that members are/can be informed at Town Meeting.

Opportunity for relatively wide participation in town governance (the fact that we have a town meeting rather than mayor-council).

Hearing the opinions of others on the motions before Town Meeting.

The opportunity to see first hand where the town spends money and how different departments are run.

TM members get to listen to all sides of an issue and vote on the merits of the issue.

Not only is data provided in advance for review, but we're plenty of opportunity to discuss articles as desired.

That each department can present articles and explain why and how much to spend on the request.

The warrants are sent out prior to the meeting for review.

## 2. The ability of TM members and registered voters to speak freely and express their views

A chance to have an input, however small, in how the town is run.

Free exchange of view, opinions and ideas.

Open forum to speak about the town article being considered.

It is a great institution that allows all registered voters to voice their opinion on the affairs of the town.

That they give the public a chance to say how they would like their town to be run (though their elected representatives).

Varying viewpoints of 200+ members have served the town well.

#### 3. Well Organized and structured

The rules provide for a streamlined manner of proposing, debating and acting upon measures.

Town officials are very prepared and make process go smoothly.

A lot of town business is accomplished in two nights per year.

#### **Question 5 - Typical Comments**

#### Question 5. What do you dislike most about Milford's Town Meeting?

#### 1. Speaker time limits

How individuals are allowed to go on too long about their point of view. Should be a time limit.

Long winded speakers.

Speakers sometimes being allowed to ramble and not speak succinctly about topics at hand.

That there is often no time limit on how long someone is allowed to speak to an issue.

The lack of time limits on speakers and people's ability to ramble on with NO end in sight.

Speakers that monopolize time speaking.

#### 2. The length of the meeting

Starts too late. Start it earlier.

Having to stay after 10:00 pm to finish the warrant.

I dislike the apparent pressure to complete TM in one night and the lack of discussion on many articles.

Too many articles packed in one session. We get out late and most of us have to get up early in the morning. I sometimes will leave early.

#### 3. Debating Issues

Circular arguments lead to unnecessarily long discussions.

Some people feel the need to argue just for the sake of arguing.

Meeting members repeating what has already be said.

Presenters who mumble, speak too softly, too loud or too fast.

When one addresses the floor and go off on a tangent.

When someone has something to say they have to walk to the front and address from the podium. Waste of time.

When debate is shut off.

Too little real discussion.

#### 4. Membership, Moderator, and Finance Committee critique

It appears that the great majority of members have never approached the microphone.

Members exiting the hall after an important vote.

Members not attending.

People who do not listen and do not come to the meeting informed.

#### 4. Membership, Moderator, and Finance Committee critique (Cont'd.)

Too many town meeting members are town employees.

And some seem clueless on how it operates.

that some seasoned members, despite having prior experience submitting amendments, continually fail to follow the required format.,

The way the finance committee gives it's take on the pre-meeting and their superior attitude towards the way they cast their decisions on spending.

Too much control by the finance committee. They are supposed to be a recommending board, not the final decision maker.

#### 5. Audio/visual system quality including speaker issues at the microphone

Speaker (audio) still not being loud enough.

Acoustics - always difficult to hear speakers.

The hall's sound system leaves a lot to be desired.

People not talking into the mike

The lack of respect many show towards the moderator and other members.

Town meeting members who can't shut up during proceedings....always the same ones. Shut up and pay attention!

#### 6. Decorum and conduct of town meeting members

Some town officials who can be condescending.

The lack of respect many show towards the moderator and other members.

Sometimes what is said is not relevant to the motion in question.

The need of some members to hear themselves speak for the sake of hearing themselves speak.

Town meeting members who can't shut up during proceedings....

Very noisy.....

#### 7. The content, clarity, and timeliness of Information provided

Information to be voted on seems to be disseminated at the last minute.

Not having an opportunity to be better informed about topics before voted on.

Planning board and zoning issues can be difficult to understand.

The order in which articles is presented seems random. Topics that require in-depth explanation and discussion should be presented first, to ensure they receive the attention they deserve. Plus, often not much information is provided to explain what is being voted on.

Written documentation should be provided that indicates what would happen if the article does not pass. (Similar to State ballot questions.)

The lack of timely information in some cases - finding material on the chair with no time to give it thorough consideration' I also feel there needs to be better visuals.

#### 7. The content, clarity, and timeliness of Information provided (Cont'd.)

Advance information not easily available. Consider taking advantage of information technology. Consider Town Meeting tab on the Town's website to post reports and You Tube links to Fin Com, Planning Board, Selectmen, and School Committee meetings that deal with the budget and Warrant Articles.

hard decisions matters should be put on agenda first NOT last when everyone is tired and no thought goes into the vote.

I find the terminology of some of the articles hard to understand.

#### 8. The same people get up and talk

The visual displays, can't see what is being shown.


#### 14. Being recognized to speak

#### 49. I feel Town Meeting Members are respectful and listen to others' comments


I see and hear too many people talking with others instead of listening to the speaker. I find it distracting and difficult to hear at times.

#### **Question 52 - Typical Comments**

#### 2. Intimidating

I have been negatively approached by members after a meeting.

They don't seem to give enough respect to the people that support or oppose an article. They seem to think it is a hassle.

#### 3. Save time

Didn't want to extend time.

Sometimes debate can get redundant. And in respect for the time and other items on the warrant we just need to move on.

In spirit of moving the agenda there's no value having multiple folks express same points.

#### 4. Shyness, anxiety, lack of confidence

Anxiety walking up to front of the room. Would prefer a microphone and be able to stay in my precinct seated area.

The reason has to do with my personality and confidence and not how the town meeting is run.

Too shy or uncomfortable.

#### 5. Nothing new to add

I have always understood the question and had enough information to vote without a question.

I would be comfortable making my voice heard if I felt that I could contribute something meaningful.

#### 6. No Reason, Futile - everything passes

90% of matters at the Town Meeting are routine and not worthy of comment. For those that are worthy of comment, a good portion of those commenting are only doing so because a microphone and audience are available

I feel it is a lesson in futility. Everything passes.

No reason.

#### 7. Not Comfortable speaking in public

I am not a person who feels comfortable speaking in front of a large audience of people I don't really know.

#### 8. New member

Coming in new last year, there was no instruction regarding process and procedure. I think this is too important to rely on on-the-job training that in fact doesn't exist. It was like facing a driving test without ever having been behind the wheel.

#### 9. Not sufficiently knowledgeable

Usually the presenters have the most knowledge about the article.

#### 10. Speaking Locations

Would be more receptive to commenting if microphones were more readily available and spread throughout the assembly.

#### 11. Difficulty Being Recognized

It is difficult to be seen and/or heard when you are located farther away from the stage. Maybe the precinct captains could help people get recognized by the speaker by holding up a sign.

It is hard to get the moderator's attention. The town meeting handbook should include example(s) of good speaking practices that emphasis the importance of making a point or asking for a point of clarification.

Question 56 - Typical Comments

1. Speaker time limits and speaker training
As long as speaker is addressing topic, there should not be an arbitrary time period set
for discussion. Some articles require more discussion /thought than others.
All officials should practice use of microphones if they are going to speak.
Repeat members get up too long too often.

#### Speaker time limits and speaker training (Cont'd.)

Speaker time should be regulated but not limited. However, the presenter of the motion and his or her designee (e.g., consultant, expert, legal representative, etc.) should be allowed all the time required to fully describe the motion. During debate each speaker's time should be regulated to afford other Members an opportunity to speak. Repetitive regulated times would continue until all speakers have been heard or a Member moves the question.

I think everyone who wants to be heard should have the opportunity. People with a spiral bound notebook full of essays that they are going to read aloud needlessly extends the length of the meeting.

#### 2. Materials and information provided

Sharpening up the individual response time allowed and having information on all articles available 3-4 weeks before the meeting would take the meeting to the next level.

Timely backup materials for each article including modern graphics, maps, charts to clearly explain purpose and need for each article (responsibility of proponent).

That and the phrase "a sum of money"... TMMs want a ballpark figure at the very least, because there's nothing worse than finding out the bill at the last minute, right before we're expected to authorize action.

Require the Fin Com to present the pros and cons of each substantive issue as required by their charter.

Require the Fin Com to reflect the votes of their members for each article not the majority vote i.e. 3 for 6 against with reasons for and against.

When watching board/committee meetings on Milford TV in prep for TM, the audio quality is often poor and inconsistent - both live and replay. This discourages one from trying to follow presentations and discussions.

#### 3. Number and duration of Town Meetings

Meeting should be planned for 2 nights. By 10:30 p.m. some members are getting restless, attention is waning, and some leave early. A 3hr. meeting is long enough. Start at 7:00 p.m.

Understandably, some of the meetings are long. But they are too long, especially for those of us who have worked a full day and are getting up early the next day.

#### 4. Electronic Voting

Electronic voting should not be done.

Electronic voting would ensure an accurate vote and not one where someone may be intimidated by standing.

#### 5. Location, seating, and audio/video

Again, I'm wide. Spread the seats out a bit. I get more elbow room flying coach. improve the audio and video quality.

Place microphones in each precinct so speakers could speak from there if they choose, too much time is wasted waiting for speakers to get to front.

#### 6. Miscellaneous Improvements

I feel that with the information that is given to TM members, such as the Finance Committee Report, we do not need them telling us whether or not their vote was favorable or not for each article, we have their report telling us such. All boards or committees do the same thing, they get up and tell us that they had a meeting. We already know they had a meeting. Time consuming.

Town Meeting Members frequently ask for more information about particular warrant articles at Town Meetings, and the sponsors (or other seemingly knowledgeable town officials) sometimes do not provide answers during the relevant floor 'debate'... if the sponsors don't have the answers, perhaps the votes should get tabled more often (perhaps automatically) to facilitate real or more-thorough answers, before a vote is actually taken.

#### 7. Pre-Town Meetings and Member Training

A meeting before town meeting to explain all warrants, what it means if the vote is yes, pro/con.

Training for new members. .

#### 8. Member attendance

Have all high important warrants for the end so members don't leave half way through the meeting.

keep the sign in attendance and keep track of those who stayed for the end

#### 9. Recognition by the Moderator

Encourage the moderator to try to see if someone is trying to get his attention.

Moderator should recognize "new" faces not same as always-speakers.

#### 10. Amendment Process

A little time should be given for someone who wants to write out a motion.
