## TOWN MEETING STUDY AND IMPROVEMENT COMMITTEE (TMSIC)

## Meeting Minutes:

3. Motions required to conclude the business of the TMSIC.

The following motions were made and approved as follows:

Motion 1: Dr. Heller moved, seconded by Mr. Long: Whereas the October 30, 2033 Special Town Meeting (Article 18) voted to dissolve the Town Meeting Study and Improvement Committee (TMSIC), effective January 25, 2024, and whereas there will be no TMSIC meetings beyond January 22, 2024, I move that the Committee approve the expenditure of the remaining funds in account #122-5938 for the printing and mailing of the Milford Town Meeting Procedural Guide and the printing and mailing of the Town Meeting Study and Improvement Committee final report to all Town Meeting members, and further that all invoices be mailed to the care of the Town Moderator (the TMSIC appointing authority) for approval and delivery to the Assistant to the Town Administrator for payment.
