Call to Order

At 6:24 pm, Chair Rickert called the meeting to order. Seconded by Steve Sousa.

A.) New Business

1. Approve Meeting Minutes: 8/16/22

MOTION: Chair Rickert motioned to approve the meeting minutes of 8/16/22. Seconded by Steve Sousa. **Vote:** All in favor by voice vote. **None opposed.** Ariea Bryan and Stacy Darling abstained as they were not present at the 8/16/22 meeting. **Motion carries:** 5-0-2

- 2. Filling vacancy:
 - a. Vice-Chair

MOTION: Jay Vaz motioned to elect Stacy Darling as Vice-Chair effective immediately. Seconded by Steve Sousa. **Vote:** All in favor by voice vote. **None opposed. Motion carries:** 7-0-0

3. Signing of warrants:

Members discussed details of a \$10,000 Warrant Article for the Special Town Meeting.

a. Basement electrical upgrade to include stage lighting, two lighted tiers for storage equipment.

MOTION: Chair Rickert motioned to submit a Warrant Article to the Special Town Meeting in the amount of \$10,000 for basement electrical upgrades: Seconded by Steve Sousa. Vote: All in favor by voice vote. None opposed. Motion carries: 7-0-0

4. CraftRoots Fundraiser 9/9 with Pub Kings (Jen Ward, Emily Stienstra):

Members discussed whether to hold the fundraiser in September (football season) or in March; end of summer; beginning of school and registrations for new and returning MYC families. Chair Rickert commended MYC staff, Jen Ward and Emily Stienstra, as the Center continues to receive *outstanding* comments on social media.

Jen Ward responded that the MYC is more than a "community" center.

Darlene Dulude said Jen Ward "upped her game" this year with outreach (business letter campaign).

 - Promotion: Jen Ward went on the radio; Emily Stienstra promoting on social media
 - Deadline is Friday, 9/9, 1:00 pm to sell tickets
 - \$100 door prize to person who sold the most tickets
 - Goal is to sell 100 tickets; 90 have been sold
 - Goal is to raise \$10,000
 - \$3,700 monetary donations received
 - Tickets can be purchased on-line and paid via Paypal or Unipay, not Venmo
 - Donations can be made via Paypal or Unipay, not Venmo
 - Raffle tickets can be purchased \$10 for a half-sleeve; \$20 for a sleeve
 - 50 raffle prizes valued > \$4,500
 - 24 baskets of community donations thanks to:
 - o Darlene Dulude and MYC Board members, the Ward family
 - Milford businesses who were sent letters to support MYC
 - Rail Trail Flatbread Co. will contribute sheets of free pizza
 - Hummus truck has been replaced with a Mac 'n Cheese truck
 - Miscellaneous:
 - o Business letters returned undeliverable; corrected and culled the list with the Town
 - Jen Ward will prepare a packet/list of Raffle Contents
 - Jen Ward will prepare a liability sign "not guaranteeing food ingredients" for food sensitive persons
 - Jen Ward gave Board members each an empty platter to bring additional food
