Meeting called to order by Mike Walsh at 7:05 pm.

- Warrants for approval and signatures including the rent invoice.
- Current balance in the revolving account is \$57,783.73.
- The Annual Town Meeting will be held on May 5, 2015. A motion by Sue Salamone, seconded by Sandra Caproni, and all in favor to submit an article requesting the town pay the salary and benefits of the Assistant Director position. Also discussed the program getting regular maintenance in the new building.
- Reminder that the Conflict of Interest and Ethics on line certificate of completion needs to be submitted to the town by April 10, 2015.
- The Renovation Committee meeting to be held on Wednesday March 11, 2015 at 7:00 pm.
- The March After-School Calendar was reviewed.
