**Milford Youth Commission Minutes
April 9, 2012**

Members Present: Sidney De Jesus, Amy Tamagni, Susan Salamone, Fran Trafecante, Chuck Calagione, Mike Walsh, Steve Manguso, and Sandra Caproni

Members Absent: Paul Seaver

- Meeting called to order by Mrs. Tamagni at 7:06 PM.
- Motion by Mrs. Salamone to accept the 03/12/2012 minutes. This motion was seconded by Mr. Walsh and unanimously approved.
- Mr. De Jesus reported that that St. Patrick's Fundraiser raised close to \$4,400. Sidney will be sending out thank you notes to all that donated.
- Mrs. Tamagni reported that Fin Com is waiting until the end of this month to accept the Milford Youth Center's budget. She will be working with Paul Abbondanza, Financial analyst, to prepare the report for Fin Com. Ms. Tamagni reported the Youth Center is reconciled with the Town Accountant.
- Mr. Walsh reported he has been in contact with the Milford Public Schools regarding contracting for vending machines at the Milford Youth Center from Polar at a 20% discount.
- Mr. De Jesus presented warrants in the amount of \$7,471.62 for approvals and signatures. This included bills from the St. Patrick's Day fundraiser.
- Motion by Mrs. Salamone to accept the policies with updates to resolve all findings of the Audited Report. Seconded by Mr. Walsh and unanimously approved.

- Discussion of the Haunter House fundraiser to take place in October. Mr. De Jesus will be preparing a tentative budget and will schedule a planning meeting to begin this process.
- Youth Combine to be held on April 25th.
- Mr. Doug Maier from Milford Youth Wrestling presented the youth wrestling program and his request for a discounted rental rate. Mr. Maier reported he has a total of 55 youth in the program. He has been using the Milford Youth Center for 6 hours per week and would like to increase this to 8 hours per week, to include Saturday hours. He would also like to continue to store the wrestling mats at the program. They charge \$125 for grades k through 3; \$150 grades 4 through 8. They provide 5 scholarships per year. The Milford Youth Commission requested Mr. Maier provide financial statements and any other supporting documents to provide us with information to make a decision about the rental rate at our next meeting.
- Spartan Soccer has contacted Mr. De Jesus about renting the gym space for their soccer league. Mr. De Jesus will request that Spartan Soccer provide the financial information for our next meeting.
- The Summer Camp budget was reviewed and discussed. An estimated budget has been prepared. Discussion whether to include lunches or not. Mr. De Jesus is working on the 8 week calendar of activities.
- Motion to adjourn made by Mrs. Tamagni, seconded by Mr. Trafecante, unanimously approved. Meeting adjourned at 8:34 PM.
