**Milford Youth Commission Minutes  
October 15, 2012**

**Members Present:** Sidney De Jesus, Amy Tamagni, Susan Salamone, Fran Trafecante, Mike Walsh, Chuck Calagione, and Sandra Caproni

**Members Absent:** Paul Seaver and Steve Manguso

- Meeting called to order by Mrs. Salamone at 7:10 PM.
- Motion by Amy Tamagni to approve the August 13<sup>th</sup> minutes. Seconded by Mrs. Salamone and unanimously approved.
- Motion by Mrs. Salamone to approve the September 10<sup>th</sup> minutes. Seconded by Ms. Caproni and unanimously approved.
- Warrants were reviewed and signed.
- Mrs. Tamagni reported the fund balance at September 30<sup>th</sup> was \$46,738.29.
- Mr. De Jesus reported the summer camp made \$6,544.68 according to the Town Accountant. There are outstanding payments of \$2,000 yet to be received from campers. These payments would put the summer camp at our projected budget of \$8,500.
- The Fire Department did not approve our proposed Halloween fundraiser citing fire concerns. Mr. De Jesus to identify another fundraising opportunity to make up money we had projected to earn through this event.
- The next Find Yourself Friday will take place on Friday October 26<sup>th</sup>.
- Mr. Calagione and Ms. Caproni have been in contact with the National Honor Society to request volunteers for the after school program and Find Yourself Friday events.
- Mr. De Jesus reported the Milford Youth Center, in collaboration with Jag, has received several grants. The Zumba Grant provides an instructor for a once a week Zumba class. \$1,000 for a Sport's Night

Grant, to be held on November 16<sup>th</sup>, which will sponsor a local child on a sport's team. The Sport's Night will take the place of the Youth Combine and be coordinated with ABT. The program also received \$1,000 from the Tutti-frutti Grant.

- Mr. De Jesus reported the Milford Youth Center received \$700 for a Ring Side Equipment Grant. He provided a budget and requested an additional \$124 to purchase the needed equipment. Motion by Ms. Caproni to approve the \$124 for the Ring Side Equipment, seconded by Mrs. Tamagni, unanimously approved.
- Mr. De Jesus will bring the storage fee rental agreement to the next meeting. He provided an update on groups requesting to rent the space including the cat show and a dog trainer.
- Mr. De Jesus reported the Milford Youth Center is averaging 100 children per day. He requested we meet to discuss staffing changes. He has met with the Town Accountant and will provide budget information for these proposed changes. Meeting to discuss staffing to be held on October 22, 2012, at 6:30 PM.
- Motion by Mike Walsh to adjourn at 8:50 PM, seconded by Mr. Calagione, unanimously approved.
